## **Summary of the RFP Intent**

As a recipient of the federal Charter Schools Program (CSP) grant, PCPCS is dedicated to promoting high-quality charter school education and providing the necessary resources and support to ensure Pennsylvania charter schools thrive. The intent of this Request for Proposal (RFP) is to solicit one or more qualified vendors to provide technical support and training services aimed at building the capacity of charter school boards and leadership teams. Our goal is to help schools achieve high-quality status, fulfill their mission and vision, and meet the legislative intent of charter schools in Pennsylvania. The services required include governance support, fiscal stewardship, operational assessment, data-driven culture development, leadership institute programs, executive coaching, and stakeholder engagement, accountability, and outreach. Interested vendors are invited to submit proposals for one or more of these services, offering comprehensive solutions that will contribute to the overall success and sustainability of charter schools across the state.

#### 1. Governance

The Pennsylvania Coalition of Public Charter Schools (PCPCS) seeks proposals from qualified vendors to provide comprehensive governance support services to charter schools. The objective is to enhance the governance structures and practices, ensuring compliance with state and federal regulations and promoting effective leadership and oversight.

# **Scope of Work**

- Review and assessment of current governance practices.
- Training for board members using a variety of modalities on topics such as but not limited to:
  - Fiduciary duties
  - Roles and responsibilities
  - Financial management
  - Legal and regulatory compliance and accountability

- Continuous improvement

# 2. Fiscal Stewardship

PCPCS seeks proposals from qualified vendors to provide fiscal stewardship services aimed at enhancing the financial management and accountability of charter schools.

# Scope of Work

- Training on financial management and compliance.
- Guidance on development or refinement of financial policies and procedures.

#### Requirements

- Experience in providing financial services to educational institutions, with a priority in serving charter schools and/or traditional public schools.
- Knowledge of state and federal financial regulations.

#### 3. Operational Assessment

PCPCS is seeking proposals to conduct thorough operational assessments of charter schools to identify areas for improvement and ensure operational excellence.

#### Scope of Work

- Identification of operational gaps and inefficiencies and areas of strength.
- Recommendations for improvement.
- Coaching and/or mentoring support.

#### Requirements

- Demonstrated experience in assessing charter school performance, leadership, governance, and operations.
- Familiarity with charter school operations.

#### 4. Data-Driven Culture

PCPCS seeks vendors to support charter schools in developing a data-driven culture that enhances educational outcomes and operational efficiency.

### Scope of Work

- Training on data collection and analysis.
- Development of data-driven decision-making processes.
- Implementation of data management systems.
- Ongoing support and evaluation.

### Requirements

- Expertise in academic, financial, and operational data systems and analytics.
- Experience in training and supporting educational institutions, with a priority in serving charter schools and/or traditional public schools.

### 5. Leadership Institute

PCPCS invites proposals for the development and implementation of a Leadership Institute aimed at building the capacity of charter school leaders.

- Design and delivery of a leadership training programs that includes:
  - Multimodality training on key topics developing charter school leadership competencies and skills.
  - Mentorship and coaching for school leaders.
  - Networking and collaboration opportunities.
- Evaluation and feedback mechanisms.

#### Requirements

- Proven track record in leadership development.
- Understanding of the charter school educational leadership landscape.

#### 6. Executive Coaching

PCPCS seeks proposals for executive coaching services to support the professional growth and effectiveness of charter school leaders.

### Scope of Work

- One-on-one coaching sessions based in performance coaching.
- Development of personal and professional goals.
- Support in addressing leadership challenges.
- Feedback and progress monitoring.

### Requirements

- Experience in executive coaching for educational leaders.
- Strong understanding of charter school leadership needs.

### 7. Stakeholder Engagement, Accountability, & Outreach

PCPCS invites proposals for services aimed at enhancing stakeholder engagement, ensuring accountability, and improving outreach efforts of charter schools.

# Scope of Work

- Support in evaluation of engagement and outreach effectiveness.
